SFC Chadwick Larter and the MA National Guard

The Massachusetts National Guard has been defending our freedoms since 1636!

Sergeant First Class (SFC) Chadwick Larter, Recruiting Non-Commissioned Officer (NCO) tells his story, in his own words. I was born and raised in

Massachusetts, I grew up in Ayer MA where I attended school and graduated from Ayer High School. I have one other younger brother who later down the road joined the US Marines. While attending school and growing up next to Fort Devens now just Devens, I developed an interest in the military and looked up to military service members. I remember

watching 9/11 happen while I was in fifth grade and at that time realized that I wanted to serve and protect my country. After seeing several of my friends in high school join the various branches of the military I decided as a 17-year-old that MA Army National Guard would be the most beneficial decision for me as it would give me the same training and skills as active-duty army, allow me to pursue a college education and start a civilian career right away. I enlisted into the MA Army National Guard at Boston MEPS at 17 years old October 31st, 2008, as a 13F (Fire Support Specialist). I chose this because it was something that no civilian job could do but would give me valuable skills that could still assist me in the civilian career.

After enlisting, and before graduating high school, I attended the Recruit Sustainment Program the MA Army National Guard offered to prepare recruits to attend basic. This training happened once every month from Friday night into Sunday afternoon. It served as a mock basic training where drill sergeants prepared us through various activities to physically and mentally prepare us to arrive to basic training prepared. This served extremely beneficial for me and the other high school students that enlisted. After graduating Ayer High School, I attended basic training and my MOS (military occupational Specialty training) at Fort Sill, Oklahoma. I learned all the



basic skills of becoming a soldier, as well as my job skills focusing on land navigation, communications, and coordinating and directing artillery fire on targets.

Following my unforgettable training at Fort Sill, I returned to Massachusetts. Being in the Army National Guard, I was able to stay within Massachusetts and conduct my service one weekend a month, and my field training for two weeks during the summer, where we would go stay in the field and practice and refine our military skill set. After returning I immediately enrolled at

Judge Debra Squires-Lee Should Show Progressive Solidarity With Migrants

And Return To Living In A Tent

When interviewed by the spineless Governor's Council after declaring she wanted "to serve" on the bench, Debra Squires-Lee recalled time spent in Arizona, California, Colorado, Montana, Oregon, and Wyoming and said "From the time I was 10 until I was 15 we were an itinerant construction worker family. We basically lived paycheck to paycheck. Sometimes we lived in tents in state parks, but my brothers and I loved living out West. We swam and fished. We played very elaborate games, and I read a ton of books."

At that point Squires-Lee had spent years as a corporate lawyer and lived in a big pile in tony Hingham (Median home price \$1.2 million). In 2014, she was one of the first to host a fundraiser in her own home for the progressive Maura Healey.

Squires-Lee first came to my attention

when she lied about Dr. Ryan Welter to favor corporate big shots. First, she arranged for his brief to be concealed from the court docket though he filed it. The clerk-magistrate is on record that he personally handed the brief to her in chambers. Squires-Lee then lied in her decision memorandum that Dr. Welter did not file that brief, before then quoting from it in that same memorandum. You can't make this stuff up. The missing brief suddenly showed up on the docket the same time as her memorandum (Case 2173CV00120). That tells you all you need to know about Judge Debra Squires-Lee. She has also made me view the Palatino typeface with ambivalence, though I had unreservedly loved it previously.

When Florida Governor DeSantis pointedly sent illegal immigrants to progressive Massachusetts a year ago, the outpouring of love and affection for

them from Massachusetts leaders was life-affirming. Then the immigrants just kept coming. As a direct result, Massachusetts natives are on course to losing the protection of a 1983 law that granted them the right to shelter. That right is going away thanks to the very progressive Maura Healey and her strong booster Squires-Lee.

Here's how that went down.

A progressive outfit called Lawyers For Civil Rights (LCR) attached the names of a couple of homeless people to a lawsuit which carefully ensured that Maura Healey's name didn't appear on it (2384CV02449 Alcarraz, Gloria et al vs. Executive Office of Housing and Livable Communities). LCR complained that Governor Healey gave the Legislature only 30 days notice before she unilaterally changed the state's shelter regulation, though the law requires the Governor to give the Legislature 90 days

to do something.

And then LCR's lawyers, Jacob Love and Oren Sellstrom, did not object when the case was handled by Judge Squires-Lee herself. I assume the homeless plaintiffs had no clue.

So, friends, you will never guess what happened next!

Squires-Lee handed Maura Healey a total victory and dismissed the case within three days flat, saying that 30 days notice was just fine.

After Squires-Lee dismissed the case, our progressive ACLU bravely filed an amicus brief, unless Squires-Lee had concealed that too from the docket.

The only question I have is, did Love and Sellstrom intentionally abuse their plaintiffs just to burnish their progressive public image knowing that Squires-Lee would of course back Healey no matter what - making this a cynical progressive

Three Groundbreaking Senate Bills Champion Consumer - Animal Protection

In a series of landmark decisions, the Massachusetts State Senate recently passed three crucial bills aimed at enhancing consumer and animal protection across the Commonwealth. Here are some of the bills that passed the Senate and are waiting for the Massachusetts House of Representatives to further consider.

1. PROTECTING CONSUMERS DURING REAL ESTATE APPRAISALS

The Massachusetts Senate has taken a significant step toward enhancing consumer protection in real estate transactions by passing S.2550—An Act providing consumers with equal protection for all real estate appraisals. This legislation aims to establish comprehensive statewide standards for real estate appraisals, necessitating that all evaluations be exclusively conducted by certified or licensed appraisers.

Presently, Massachusetts law permits individuals, regardless of their education or experience, to perform valuation services for various purposes, such as estate settlements, divorces, and business dissolutions. This lack of regulation exposes consumers to undue risks, as unlicensed individuals may offer unsupported valuations without accountability or oversight. Moreover, the absence of licensure leaves consumers with no recourse through the state’s Division of Occupational Licensure when harm occurs.

In stark contrast, 42 other states ensure consumer protection by mandating the involvement of certified or licensed appraisers in all real estate

appraisals, according to the Appraisal Subcommittee of the Federal Financial Institutions Examination Council. Massachusetts currently falls short in safeguarding consumers, as licensing is only obligatory for federally related transactions like certain mortgages. This gap allows unlicensed individuals to conduct real estate valuation services for any other purpose.

The proposed legislation outlines stringent criteria for individuals seeking state certification or licensing for appraisals. These standards include completing 200 to 300 hours of classroom appraisal education, passing exams, participating in 15 hours of classroom instruction on the Uniform Standards of Professional Appraisal Practice, accumulating 1,000 to 3,000 hours of supervised appraisal experience, passing a 4- to 6-hour national licensing examination, and completing 28 hours of continuing education every two years, with 7 hours focused on the Uniform Standards of Professional Appraisal Practice.

Real estate appraisal professionals strongly support the effort to increase appraisal licensure, emphasizing the importance of qualified professionals in the appraisal process. With the Senate’s approval, the legislation now advances to the Massachusetts House of Representatives for further consideration, marking a critical move toward standardized and consumer-focused real estate appraisals in the Commonwealth.

2. PROHIBITION OF CAT DECLAWING IN MASSACHUSETTS

In a dedicated effort to safeguard the well-being of feline companions, the Massachusetts Senate has unanimously

passed S.2552—An Act prohibiting inhumane feline declawing. If enacted, this legislation would position Massachusetts as the third state in the nation to prohibit the cruel practice of declawing cats, permitting it only in cases of medical necessity as determined by a licensed veterinarian.

The act of declawing involves the amputation of the first bone on each toe, while tendonectomies entail cutting a tendon in each toe responsible for controlling claw extension. Cats subjected to declawing procedures are at an increased risk of experiencing various health issues, including paw pain, back pain, infection, tissue death, and potential difficulties in using their legs properly. The Humane Society of the United States reports that declawed cats are more prone to nerve damage and bone spurs due to claw regrowth. It is important to note that declawing is often performed for human convenience and to prevent damage to furniture, rather than for medical necessity.

The legislation specifically targets the prevention of declawing for non-medical reasons, introducing civil penalties for violations. This groundbreaking move positions Massachusetts alongside New York and Maryland as the third state to institute a ban on declawing, eliciting commendation from prominent animal rights and welfare organizations, including the MSPCA-Angell, the Animal Legal Defense Fund, and The Humane Society of the United States. As the bill progresses, advocates hope it sets a precedent for humane treatment of animals, signaling a positive shift in the approach to feline welfare across the nation.

3. WHEELCHAIR WARRANTY REFORM

In a unanimous decision, the Massachusetts Senate gave the green light to S.2541—An Act expanding wheelchair warranty protections for consumers with disabilities. This law beefs up the rights of wheelchair users, making it mandatory for all wheelchairs to have warranties, extending the

minimum warranty period to two years, and laying down standards for repairs and replacements.

Under this law, all wheelchairs sold or leased in Massachusetts must now include express warranties. This is a notable change from the current rule, which only requires express warranties for customized wheelchairs. The legislation also extends the warranty period for wheelchairs from one year to two years, aligning Massachusetts with states like Rhode Island and Connecticut.

To address delays in repairs, the bill insists that wheelchair service providers remotely diagnose repair issues within three business days after a consumer reports a problem. An in-person assessment must then be provided within four business days.

If a wheelchair user can’t use their in-warranty chair during repairs, the bill mandates that manufacturers or dealers either reimburse them or provide a loaner wheelchair within four business days for most wheelchairs, or within eight business days for highly customized ones.

The bill further requires manufacturers and dealers to cover any additional costs during the repair process for in-warranty wheelchairs. For out-of-warranty wheelchairs, the legislation puts a stop to insurers requiring consumers to go through a complicated prior authorization process for repairs under \$1,000. Additionally, the bill empowers the Attorney General’s office to take legal action against service providers engaging in unfair or deceptive practices.

Now, as the legislation heads to the Massachusetts House of Representatives, advocates are optimistic about its passage, solidifying Massachusetts as a leader in protecting the rights of individuals with disabilities. Notably, a similar version of the legislation passed the Senate in 2022, but unfortunately, it did not progress further in the legislative process. ♦

Investigating Fraud in Our Public Benefit Programs

Much of our focus in the State Auditor's Office is on conducting audits and reports that identify ways state agencies and organizations can improve accessibility to government services and resources, while helping to ensure greater accountability and transparency across our state government.

I'd like to share a bit about the incredible work of our Bureau of Special Investigations (BSI) unit, a team dedicated to strengthening the social safety net in Massachusetts by investigating potential fraud in our public benefit programs.

This unit investigates programs administered by the Department of Transitional Assistance (DTA) and the Division of Medical Assistance, which administers MassHealth. In addition, BSI has an agreement with the Department of Early Education and Care (EEC) to investigate fraud in that program as well.

Our team continues to focus on ways we can help make a meaningful impact by improving best practices, increasing accessibility to resources and programs, and helping identify ways we can hold organizations accountable across state government. BSI's annual report highlights their critical work during the

last fiscal year.

BSI receives referrals for investigation from its agency partners, public tips, federal agencies, and through the use of its data analytics tools. The public can report potential fraud to BSI online at <https://www.mass.gov/how-to/report-public-benefit-fraud-to-the-office-of-the-state-auditor> and via phone at (617) 727-6771. Complaints are always confidential.

As we continue to develop new practices, in collaboration with other state agencies, to help identify potential

fraud, more cases are identified and evaluated. The increased workload is possible with advanced data analytic tools and new pathways of communication. For example, our work with DTA is essential and, as they become aware of a potential fraud case, BSI is able to automatically begin investigating the situation.

Catching fraud early and preventing our tax dollars from being wasted ensure that families who truly need this helping hand are not left in the cold due to bad actors. During this past fiscal year, the

total amount of fraud BSI identified was \$12,322,688, with 5,100 investigations completed - a 40.8% increase from FY22. 782 of those cases had fraud identified.

Another important role BSI has in reporting fraudulent cases is the ability to recommend cases for prosecution to the most severe cases of fraud to the Attorney General's Office (AGO) after considering the intent and the potential to serve as a deterrent to future fraud.

Public assistance is meant to be of service for folks in need. Even if we can't imagine ever needing assistance, these programs can provide vital services and serve as a social safety net for all of us. That is why my office will continue to promote accountability to ensure these programs are preserved by helping to catch fraud and misspending.

Maura Healey Kicks Off Black History Month By Closing Recreation Center in Roxbury

Massachusetts Governor Maura Healey has chosen the perfect way to show how Democrats care about disadvantaged Black citizens with her decision to close the Melnea Cass Recreation Complex in order to house illegal aliens on the first day of Black History Month. The complex, located at 120 Martin Luther King Jr. Blvd. serves some of the most disadvantaged Black residents of the Commonwealth. Governor Healey's action is the latest of her administration's and Beacon Hill Democrats' failure to address the influx of illegal aliens into Massachusetts thanks to our reckless right to shelter law. This, in addition to other measures designed to attract illegal aliens to the Commonwealth, underscores how the Democrats truly

view the interests of US Citizens, especially our most disadvantaged. These being the people they pretend to care about.

Melnea Cass, known as the First lady of Roxbury, was a civil rights activist and proponent of women's suffrage. She worked to organize Black citizens, and, after ratification of the 19th Amendment, helped register women to vote. Bear in mind no Democrats in either the House or the Senate voted in favor of the 15th Amendment, which gave lacks the right to vote. On the 19th Amendment 94% of House and 74% of Senate Republicans voted Yea while 40% of Democrat House members and 57% of Senate Democrats voted against it. Mrs. Cass was the President of the Boston branch of the NAACP from 1962 to 1964. The center that bears her name which Gov. Healey

has appropriated was originally dedicated in 1967 by Republican Governor John Volpe. On May 22, 1966 then Massachusetts Attorney General Edward W. Brooke honored Mrs. Cass, and that day was declared Melnea Cass Day. Edward Brooke, a Republican, went on to become the first AfricanAmerican since 1874 to be elected to the Senate, and the first AfricanAmerican ever to be re-elected to the US Senate. With all that Republican involvement is it any wonder Governor Healey wants to erase Mrs. Cass's legacy?

Roxbury is a microcosm of the failures of Democratic policies. Poverty and crime are rampant. The boulevard that bears Melnea Cass's name is part of "Mass and Cass" where addicts line up homeless in the streets. Why there? Why is help not afforded them? The

Democrats certainly rely on the 90%+ of their votes they get every other November, but the rest of the time?

Governor Healey's decision to make this move on the first day of Black History Month is a fitting tribute to the party of slavery, the KKK, and Jim Crow's true feelings about disadvantaged Black American citizens. I am pleased to report that a new investor has invested in Steward Hospitals. This will allow both Holy Family, Haverhill, and Methuen, to keep their doors open to the public. This will allow the hospitals to expand some of their care.

This news has reassured all receiving services or working at Holy Family. I can promise you that we will still be working with both Steward and the State to ensure that we have a long-term plan to keep Holy Family open for the residents of the Merrimack Valley.

This past week, I had the pleasure of visiting the Tenney Grammar School in Methuen to listen to the eighth-grade class's presentation of their civics projects. They did not disappoint. These students were prepared and delivered informative presentations about the project they decided to undertake.

These projects, to name a few, range anywhere from community gardens to solar farms and passes so that students' parents and administrators knew which bus they had taken to get home that day.

The time and research that went into preparing these projects shows the



dedication and the lengths the students are willing to go to make their school and community a better place.

I also got the opportunity to sit down and have lunch with the leaders of each project. We discussed what I do for work, where they planned on attending high school next year, and who would be winning the Super Bowl this year. Why I Support the HERO Act

As we embark on another legislative session, I am filled with enthusiasm to serve you, the resilient members of our community. The 4th Essex District and the entire state of Massachusetts rely on elected officials to protect their needs and better their environment, schools, health, and more.

There are a plethora of important bills which touch on these topics. I hope to see many of them made into law this year. While I have your attention here, I would like to use this space to advocate for one bill in particular- the HERO Act. The HERO Act, H.4172 filed by Governor Healey, is now before The Committee on Veterans and Federal Affairs of which I am a member. I want to begin by expressing my support of this legislation along with my solidarity with veterans.

The HERO Act can be understood from three major categories: benefit expansion, commitment to inclusivity and greater representation, and modernization of veteran services. These are broken down based on policy incentives, tax credits, and statute changes. Benefit expansion is needed now for veterans. With inflation and high rent, we must increase annuity



accordingly. The HERO Act will do just that. Another key measure under veteran benefits is access to behavioral health treatments. We cannot let our veterans suffer alone.

This act will reimburse outpatient behavioral health care visits. A third, but not final, measure under benefit expansion has to do with lengthening the timeframe for veterans to participate in the Active-Duty Service Buyback program. We heard testimony from many veterans who expressed difficulty with managing their enrollment in this program in 180 days or less. This

bill wants to alleviate that stressor by expanding that timeframe to 10 years.

The second key goal of this bill, commitment to inclusivity and greater representation, makes long overdue changes that will largely support our women, minority, and LGBTQ+ identifying veterans. The first step here is to expand the definition of 'veteran' to allow for more veterans to apply for annuity. The current definition in Massachusetts lags behind the federal definition. This change will more closely align the two. It will also update

the definition of a veteran dependent to match the definition used by the Probate and Family Court.

The final key measure I will mention here is the creation of a pilot program to support same-sex couples who have been denied reimbursement for IVF treatments under the Veterans Health Administration. This is more inclusive to same-sex couples who wish to have a family and get the same support as veteran couples of the opposite sex. I support these changes because all veterans deserve to be recognized and supported equally.

Veteran services are desperately in need of modernization. The modernization detailed in H. 1472 includes language, standardization, mental health support, overall healthcare, and the operation of veteran cemeteries. It has been too long since state officials have come together to pass updated legislation for our veterans. I am proud to take this stand for veterans now.

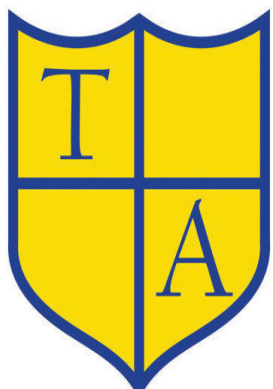

EMERGENCY PARKING BAN: Alternate Parking on Certain Streets between 12:01 AM to 6AM

The winter alternate parking ordinance shall only take effect during the dates and times specified in a "SNOW AND ICE EMERGENCY" issued by the Mayor or his/her designee, The snow emergency shall remain in effect until the Mayor rescinds it. Notice of any such rescission shall be given in the same manner as the issuance of the declaration.

Winter Alternate Parking shall mean that on the following streets, between the hours of 12:01 a.m. and 6:00 p.m., daily, vehicles shall, unless otherwise prohibited by law, be parked on one side of the street only, so that on the even-numbered dates of the calendar, vehicles shall be parked on the even-numbered sides of the streets, and on the odd-numbered dates of the calendar, they shall be parked on the odd-numbered sides of the streets: **ORD 10.36.031 (*IF YOUR STREET IS NOT LISTED BELOW, NO PARKING IS ALLOWED*)**

A Partnership Between Lowell High School and Middlesex Community College

Kane learned that all students at Lowell High School are eligible to attend college level classes at Middlesex Community College while enrolled in their junior and senior year of high school. Kane thought this was a great way to earn college credits at no cost to the student, expose students to the college setting, and get a jump start on earning credits. "Can you believe that students could actually graduate from high school with up to a year of college credits already completed?" said Kane. These students are meeting the requirements for high school and college at the same time. The requirement for credit is passing the course.

Kane knows that saving money is very important. Did you know that the Early College Lowell program saves students a full year of tuition estimated to cost between \$8,000.00 and \$10,000.00 at an in-state community college. Not only is tuition covered, but students also receive a laptop, and the cost of books and materials are covered for each class. Three credit classes are

taught to juniors and seniors on campus, where students can experience the college classroom and participate and student activities and services. Kane was excited to learn that one credit freshman and sophomore classes were offered at Lowell High School. These classes are attended by all Lowell High School attendees. The curriculum focuses on career development, interest surveys, and value clarification. Another one credit class focuses on healthy decision making.

Kane wondered what type of support services are available. He learned that support professionals are available at both Lowell High School and Middlesex Community College. Services provided include helping students with career planning, assisting in selecting classes, linking students with tutors, mentors, and student advisors, and offering workshops to students and parents. To be admitted into the program students are required to fill out an application and provide their high school transcripts. Junior and Senior participants are asked to complete an additional year of college after graduation. Kane thought that was extremely smart since at the end of that year the student would

After a student earns an associate's degree, Early College Promise allows students to transfer their credits to a 4 year in state school to work towards a bachelor's degree. Kane was interested in learning what classes and majors of study were available. He would like to share this list with you of potential classes - Graphic Design, General Biology, Public Speaking, Film and Society, Introduction to Engineering, English Composition and Intro to Psychology, to name a few.

Like you, Kane loves to see students excited about learning and focused on a career path that feels purposeful and personally fulfilling. He was excited to learn about this opportunity for Lowell High School students. The Greater Lowell Tech has a similar opportunity. As Kane always says, "keep your eyes open when opportunity knocks."

Good News for Lawrence Police Firefighters Want Fairness

Congratulations to the Lawrence Police for finally securing a well-deserved contract from the city. It's truly a commendable achievement for the department after years of advocating for fair compensation.

However, it's hard not to express disappointment when juxtaposing this success with the city's failure to offer a similarly respectful contract to the firefighters of Lawrence. Local 146 took the city for their word when they were repeatedly told that there was no money beyond the 3% COLA offered, while seeking a contract similar to the Police Department, including an additional 2% for hazardous duty pay, a benefit received by many similar fire departments in the Commonwealth. The sudden settlement of the police contract after the city's repeated claims of financial constraints does raise questions and frustrations.

The question of whether the administration really believes Local 146 wants to get every dime that they have is not a valid one. It's essential to underscore that fair, sustainable contracts benefit both the firefighters and the community they serve. Many members of Local 146 are from the city and are committed to giving their all for the next 30+ years in providing the highest quality of service to the residents, business owners, and visitors of the City of Lawrence.

The disparity becomes all the more glaring when considering the significant budget increases, particularly the mayor's budget almost doubling, along with substantial wage increases for non-union inner circle members. Additionally, the stark contrast in wage increases between the police and the firefighters during the same 3-year period does raise



concerns about equity and fair treatment.

The recent settlement of the police contract, including a 3% raise each year for the next three years and a 2% increase for the post commission, certainly highlights the need for transparency and equitable treatment across all public service sectors. Such disparities only emphasize the need for fair and just treatment for all public servants.

The disparity in treatment becomes starkly evident when one considers the dedication and hard work put in by Local 146 Lawrence Firefighters, who have not been given the same consideration. The support and endorsement provided by Local 146 to the administration only adds to the frustration, as they find themselves seemingly relegated to a back seat despite their contributions and support.

If the city was being honest about its finances when negotiating and finalizing a contract with Local 146 but moments later found they did have the money to pay the police what firefighters were also asking just weeks after settling with firefighters, the administration should do the right thing and offer an MOA to firefighters, offering that same 2% increases over this contract to show the respect for both departments is equal.

The Bellwether Tolls

I now have proof the Town of Dracut never ratified the United States Constitution. And with the likes of Alison Genest, Joseph DiRocco, and Jennifer Kopcinski, I don't hold much hope for it in the future. At a Zoning Bylaw Review Committee meeting on January 11th, the Chairman informed members of the public, and in particular myself, that participation in the public meetings would no longer be permitted. This is government work, and the public cannot interrupt those who will make the rules that the unwashed must follow.

What is even more disturbing than this incident, is the preceding events leading to the expulsion of public input. Chair Alison Genest is a process fanatic. She needs to be since she really has no thought other than power and how to maintain an iron rule. Process is an ignorant man's politics. She has convinced the Chair of the ZBRC, that committee is not to do the best work they can. They are to do the "will of the Selectmen," specifically, the Troika listed above.

There is a lot to unpack after the last Zoning Bylaw Review Committee meeting on January 11th. The Selectmen have been trying to ramp up participation by the town citizens for years. Alison Genest has now forced a committee seeking citizen participation to renege on that promise to include the public. The takeaway is that the government is more important than the public voice. "You the people," the squalid masses, will do what you are told. You will dine on the sausage being made for you without contribution, for those with food allergies, you may need to go hungry.

The Gang of Three have also convinced Town Counsel to provide cover in the form of justification to the prohibition to public input. Providing rationalization rather than legal advice, Counsel went on a diatribe about public meetings getting out of hand and degrading into complete mayhem. Counsel has little faith in the Chair of the ZBRC maintaining order with the public. Counsel's opinion goes squarely against that of the State Attorney General and the Guidelines for Open Meetings. "Although public participation is entirely within the chair's discretion, the Attorney General encourages public bodies to allow as much public participation as time permits." Alison Genest has

little regard for the opinion of others: appointed officials, elected officials, or the public.

It is just a matter of time before Alison Genest and her cohorts will try to lay claim on every board and committee within town. Genest has already asserted that her position as someone elected is dominate to all others. The appointed boards are by that logic subordinate to those elected. Genest has taken it upon herself to manipulate all autonomous boards. This whole incident of restricting public participation by the public during a ZBRC meeting is only the first barrage. Genest could have simply taken her issues to the ZBRC Chair and questioned his decision, but in her mind, he is the hired help and is not entitled to an opinion that differs from hers. How long will it be before the Planning Board or Zoning Board of Appeals must acquiesce? What about the Finance Committee, a committee appointed by the Town Moderator, an elected office. "None can oppose the will of Sauron." Alison Genest's leadership only brings divisiveness and chaos.

The upcoming election will have far reaching ramifications. This year is a single seat. The Selectmen are elected in a rotation series over a three-year period. Two seats for each of two years and a single seat for the last of the three-year cycle. The lone seat has been held over the past five terms by Joseph DiRocco. He has not only enabled Alison Genest's style of government, but he has also cultivated it in this farming community. Genest's government is similar to DiRocco's own style of intimidation and retribution, she is a faithful apprentice. DiRocco's last victory had him proclaiming this would be his last term. He lamented the negative campaigning by the opposition, when it was in fact his own negative political record being brought to light. Dorian Gray's picture is handsome compared to DiRocco's and Genest's.

An informed citizenry is the best bellwether for a good government. Understand those who you are voting for. Question the candidates on their ideas and their assertions. The truth does not mind scrutiny, deception cannot abide interrogation. Once the election is completed, stay informed. Continue to ask questions. Dracut Hall is like Tammany Hall, Joe DiRocco and Alison Genest smirking "what are you going to do about it." ♦

No More Divide and Conquer in 2024 America

The concept of original sin has fueled a global debate since even before the dawn of Judeo-Christian thought. Born a Crime, written by former Daily Show host Trevor Noah, is a fascinating book about him being ostracized by many groups in South Africa because of his mixed race. Interracial marriages and relationships were strictly forbidden. If the authorities found out that Trevor’s parents (a white European dad and a Black South African mother) gave birth to a mixed-race child, both parents would have been arrested and jailed for years.

The evil genius of South Africa



apartheid was that whites, other races and even tribes were assigned regions to reside and were pitted against one another. Sanctioned geographical divisions, tribal animosities and stereotypical behaviors ran rampant, which was exactly the mission of those in power. The parallels are striking in how Radical Left America identifies certain people despite flourishing diversity, judges the motives of other groups without learning history’s wrongs, and hosts separate public events without inviting others. Police Finally Release Info on Killing of Alex Talcott

The Durham, NH police department has finally released information on the murder investigation of Valley Patriot columnist and Republican political operative Alex Talcott.

NHinfo.com posted the following story on Thursday February 1st:

"The Death Of Alexander Talcott has been ruled as justified deadly force by Kristin Talcott after she was attacked by her husband. NH Attorney General report just released says:

"Accordingly, based on all the facts and circumstances known to Kristin Talcott at the time she used deadly force against Alexander Talcott, it was reasonable for her to conclude that her husband was using unlawful deadly force against her and that her own use of deadly force was necessary to prevent his further violent aggression.

Therefore, no criminal charges will be filed against Mrs. Talcott in connection with the death of Mr. Talcott because Mrs. Talcott justifiably used deadly force to defend herself.

The details of what happened in the fatal stabbing, and what led up to it can be read in the full 16-page report posted on NHinfo.com.

According to the report:

At about 2:30 a.m. on August 26, Mrs. Talcott called 911 using her cellphone.

She was audibly distraught throughout the call, which lasted about eight minutes.

Mrs. Talcott reported her husband had attacked her and was injured and "dying," and she was bleeding. Mrs. Talcott explained that her husband "found out that I was trying to get away" and recounted that she "got the knife back" and "stabbed him in the neck because he was attacking me."

Mrs. Talcott said that she was calling from the bedroom and could see her husband in the bathroom, but when asked whether he was breathing, she explained, "I can't go in; I'm too scared."

The call ended when the police arrived at the house."

Nothing within the report explained why Durham, NH police and the Attorney General's office made an unprecedented decision to conceal the name of the murder suspect (Kristen Talcott, Alex's wife), for five full months leaving the community to speculate, and leading to rumors running wild within the community and on social media.

The NH Attorney General's office said that more information on the investigation would be released shortly.

**BENEATH THE SURFACE
WITH PAUL MURANO**

The Taylor Swift Phenomenon

Like every normal guy who doesn't have an adolescent daughter, I knew almost nothing about Taylor Swift. What I've heard is she's a lingering pop star capitalizing on young women's tribulations with former "relationships" – a kind of a #MeToo of rock.

Additionally, as a long-fulfilled (and recently suffering) New England Patriots fan, I'm a follower of the NFL, despite its recent ("End Racism") turn to wokeism. So, I'm fully aware of the Kelce-Swift phenomenon that is capturing the imagination of the gossip media, and more recently cable news, all the way to the Super Bowl. Whether it's all genuine or tainted for purposes of publicity or politics, I don't know and don't much care.

What I do find appalling, however – and all of us should – is the cultural ethos that has led millions of girls and young women for decades to take solace in the lamentations of artists like Swift and Alanis Morissette.

The modern world, infected by the sexual revolution, has created the fundamental ethic of adult consent to differentiate what is morally acceptable from unacceptable. If one consents to something, it's good; if not, it's evil. This is what the #MeToo movement and our society at large does not understand: Abuse is not defined simply by a lack of consent.

The realm of sex is very different from other parts of human nature and carries with it deep implications. Sex outside of marriage violates people at their core, and no adult consent or capricious denials can ever change this. It leaves people wounded and jaded. Just listen to the lyrics.

This artificial demarcation of adult consent was created in part so that men may use women without consequence and women may feel "empowered" as being equal to men. The result has been 80 million abortions, a 50% divorce rate, a soaring suicide rate, countless people trying to cope with prescription meds, and the Alanis Morissettes of the world screeching from the depths of their being, at least internally, "I'm here to remind you of the mess you left when you went away. It's not fair!" (You Oughta Know 1995)

Isn't it interesting that this common experience of lifelong woundedness has still not been motivation enough to stop



the revolution in its tracks. This futility is a testament to the addictive power of sex, when reason is forced to take a back seat. Have you ever suggested in public that pornography be outlawed? Watch the visceral reaction you get from those who use free speech as their pretense.

There was a reason that sex was held to be reserved for marriage for several millennia before the revolution. It was understood by most that it was the unique privilege of committed spouses expressing and confirming their lifelong covenantal bond. This norm of the natural law protects people from lasting wounds, preserves love as an unconditional commitment, and provides a secure environment for potential offspring to be welcomed.

The message coming from parents, pastors, friends, and the media must be clear and unambiguous, albeit counter-cultural. Until we communicate this truth with courage and conviction, the powerful in society will continue to make money off people's pain. And even sadder, formerly innocent women like Brittany Spears, Alanis Morissette, and Taylor Swift will continue to be poster girls for this faux "female empowerment" movement – whose end is pain, bitterness, and broken dreams.

THE DOCTOR IS IN!

Why Doctors are Leaving

Greetings.

I was asked to write on :

- Why doctors are leaving
- How to find a really good doctor
- Signs and symptoms of serious ailments

The first issue is easier to talk about, but I will try to answer all three questions

1) The insurance companies slowly but surely took over the medical world. These guys are investors and of course, the bottom line is their basic goal. They now control almost every step of our job. As doctors, we have to see more patients to make a living. We have to ask the insurance to approve a patient's workup and medications. Cancer and autoimmune medications are expensive and approval often takes time. Patients have the doctor in front of them and take out their justified frustrations on us. Some doctors were shot dead for delaying treatments. Between the regulations, the punitive atmosphere, the angry patients, life became too stressful to accept. Early retirement or change from clinical to administrative work became a way to deal with the stress and anxiety. A surgeon pays close to 200 thousand in malpractice insurance. Overhead is getting more than the income.

Meanwhile, many nurses were told that they can become nurse practitioners and do.

The job that doctors do. This was very attractive for them. So many excellent nurses joined the NP profession. They do 500 hours of hands on training during their clinical studies.

I calculated that doctors do close to twenty thousand hands on during their training. These are cold facts. The nurse

practitioners and physician assistants are very competent and highly educated professionals. Yet I think that they still need oversight by a physician. But the physicians are not there. Massachusetts has signed a decree that they do not need to work with a physician.

2) With the above in mind, you should be able to know how to find a good physician or nurse practitioner for your primary care. The specialties follow a different paradigm and they have less of this kind of problems than primary care. The reviews online are not reliable because people judge only the kindness and attention, which although important, does not always correspond to the medical competence.

Patients can advocate for themselves only to a certain degree, but it is very hard because they are not usually clinicians. It should not be our job to double check every doctor's or NP's decision.

3) As for the third question, different serious ailments present differently. My quick response is go with your gut feeling. I would add that often a feeling of severe anxiety comes with serious physical diseases, like heart attack, meningitis, a bleeding ulcer, a pulmonary clot, etc. Somehow the brain knows that something is not right. Fever, difficulty breathing, fear of moving or talking for unknown reasons, poor balance, lower vision, high or very low pulse, skin mottling, all could presage a serious dysfunction and require an emergency room urgent visit.

It is often better to call an ambulance rather than getting driven to the ER in case initiation of treatment needs to be started on the way.

“Colin From Accounts”

‘Colin from Accounts,’ my recommendation for this month, is the story of two single strangers brought together by an accident. Ashley (Harriet Dyer), a 29-year-old medical student, is on her way to a safety seminar at the hospital when fortysomething microbrewer Gordon (Patrick Brammall) stops his car to let her cross the road. To thank him – and cheer herself up – she pulls the side of her top down briefly and goes on her way. Until, just behind her, she hears the sound of a distracted driver running over an unaccompanied dog.

Before you know it, they are on the hook for a \$12,000 vet’s bill and Ashley has moved into Gordon’s place to help take care of the dog while she looks for an apartment that will allow pets. Since the dog has no collar or tags, they decide to name him Colin. Jokingly they call him Colin from Accounts, but the name Colin sticks.

Thus begins the relationship of Gordon and Ashley, who would never have met at all without this incident. But whatever attraction there is between them, there’s a bigger issue — namely, the age gap between them. Colin is somewhere in his 40s and Ashley is 29. She doesn’t get his old man references — When Harry Met Sally, butlers traditionally being named Jeeves — but the gap becomes wider as things progress.

What follows is a very well-done, surprisingly insightful, and well-rounded romantic dramedy. Brammall and Dyer, real-life husband, and wife and who also wrote and created the show, are perfectly capable of not just carrying the episodes, but also being

funny at the correct beats and elevating their story arcs in unexpected ways.

The show is realistically written too, Ashley being portrayed as an honest representation of someone who’s having a bit of a tough time and coming up against constant hurdles that someone in her position would face. Her landlord selling all her possessions without her consent; her toxic mother showing up unannounced at the worst possible times; her ex-boyfriend and current colleague being an all-round jerk to her as she nurses a bruised heart. Gordon is also having a hard time, going through nerve-wracking checkups after undergoing treatment for cancer.

We are also spared the cringey dialogue that you get in many romantic comedies these days. The show doesn’t get corny. It’s honest and messy and complicated, as most love stories so often are. The series shows that, with the right set of actors, you don’t need to go overboard with physical comedy or over-the-top situations, and that life can be funny and tragic in its own way.

Besides the great chemistry of the two leads, the rest of the cast shouldn’t be overlooked either. The supporting actors are all terrific. All in all, ‘Colin From Accounts’ is charming, compelling, and comedically convincing.

Speak Lord!

God Bless you all in the Powerful Name of our Risen Lord and Savior, Jesus Christ!

When you read these words, “Speak Lord,” what are your initial thoughts? Do you really think that it’s available in 2024 for the Lord to speak? To speak to you? Yes, you!

Jesus said in John 10:27, “My sheep hear My voice, and I know them, and they follow me.” NKJV. In the Old Testament, the children of Israel had to go to a designated place, the tabernacle of meeting to hear God speak as it says in Exodus 29:42-46, “This shall be a continual burnt offering throughout your generations at the door of the tabernacle of meeting before the LORD, where I will meet you to speak with you. 43 And there I will meet with the children of Israel, and the tabernacle shall be sanctified by My glory. 44 So I will consecrate the tabernacle of meeting and the altar. I will also consecrate both Aaron and his sons to minister to Me as priests. 45 I will dwell among the children of Israel and will be their God. 46 And they shall know that I am the LORD their God, who brought them up out of the land of Egypt, that I may dwell among them. I am the LORD their God.” NKJV. So, as we read, in order to hear God Speak they had to go to a special designated place.

In the New Testament, things changed! We read the following in John 14:16-18, “And I will pray the Father, and He will give you another Helper, that He may abide with you forever, 17 the Spirit of truth, whom the world cannot receive, because it neither sees Him nor knows Him; but you know

Him, for He dwells with you and will be in you.” NKJV. Then in John 16:13-15, “However, when He, the Spirit of truth, has come, He will guide you into all truth; for He will not speak on His own authority, but whatever He hears He will speak; and He will tell you things to come. 14 He will glorify Me, for He will take of what is Mine and declare it to you. 15 All things that the Father has are Mine. Therefore I said that He will take of Mine and declare it to you.” NKJV.

Today as Christians we have the Holy Spirit in us forever! He never leaves us! Meaning you can’t lose your salvation because your salvation is based upon the perfect finished work of Jesus Christ on the cross. The innocent one, Jesus, freely gave His life for us, the guilty ones! So, God speaks to us, those who are saved by Grace, through the Holy Spirit who lives in us. The designated place God speaks to us today is in our spirit which is in us.
